JUDGE CODE OF CONDUCT PRIVACY MOOT COURT COMPETITION 2023

As a judge for the Unwanted Witness Privacy Moot Court Competition, I recognize that my role is critical in ensuring fairness, impartiality, and professionalism throughout the competition. To that end, I commit to abide by the following code of conduct:

Impartiality: I will remain impartial throughout the competition and make decisions based solely on the arguments and evidence presented before me. I will not allow my personal beliefs, biases, or preferences to influence my judgments.

Preparedness and Diligence: I will prepare for the moot court competition and will conduct myself with diligence and care in reviewing the materials presented, asking questions, and evaluating the arguments.

Conflict of interest: I will disclose any potential conflicts of interest that may affect my ability to remain impartial and fair. If necessary, I will recuse myself from any case where my impartiality may be compromised.



Adherence to Rules and Procedures: I will adhere to the rules and procedures of the moot court competition, including the time limits, evidentiary rules, and other guidelines established by the organizers.

Feedback and Critique: I will provide constructive feedback and critique to the competitors and coaches, highlighting their strengths and weaknesses, and providing suggestions for improvement.

Integrity and Ethics: I will maintain high standards of integrity and ethics in my role as a judge, avoiding conflicts of interest or any actions that may compromise my impartiality.

Continuous Learning: I will engage in continuous learning and improvement, seeking to expand my knowledge and understanding of privacy law, moot court advocacy, and related fields.
