



UNWANTED WITNESS PRIVACY MOOT COURT COMPETITION 2024 RESIDENTIAL RULES AND REGULATIONS

1. Preamble

The Unwanted Witness Privacy Moot Court Competition (the "**Competition**") is a prestigious event that requires the highest standards of conduct from all participants. To ensure a conducive environment for all, the following Residential Rules and Regulations (the "**Rules**") are hereby established. Compliance with these Rules is mandatory for all participants. Violation of any of these Rules may result in severe consequences, including disqualification from the Competition or dismissal from the accommodation.

2. Prohibited Conduct

2.1 Alcohol and Drug Use

- The possession, consumption, or distribution of alcohol, illegal drugs, or any controlled substances within the accommodation premises is strictly prohibited.
- Any violation will result in immediate disqualification from the competition and dismissal from the accommodation.

2.2 Sexual Harassment

- The competition upholds a zero-tolerance policy towards sexual harassment in any form, including unwelcome advances, requests for sexual favors, and other verbal or physical conduct of a sexual nature.
- Any report of sexual harassment will lead to an immediate investigation and, if substantiated, result in disqualification and dismissal from the competition.

2.3 Weapons

- The possession or use of weapons of any kind, including but not limited to firearms, knives, and other harmful objects, is strictly forbidden.
- Violation of this rule will result in immediate disqualification and notification to the appropriate authorities.

3. Accommodation Regulations

3.1 Respect for Property

- Participants are expected to respect the accommodation facilities and the property of others. Theft, damage, or vandalism of any property, whether belonging to the accommodation or to fellow participants, is strictly prohibited.
- Mooters shall be personally responsible for any damages caused by them and will be liable to compensate for any such damage. Violation may result in disqualification.

3.2 Visitors

- Hosting or allowing visitors in rooms or any part of the accommodation without prior written permission from the competition organizers is strictly prohibited.
- Unauthorized visitors will lead to immediate disciplinary action, including potential disqualification.

3.3 Maintenance Issues

- Mooters are required to report any maintenance issues, including damages or malfunctions, to the designated competition liaison immediately.
- Failure to report issues that result in further damage may lead to penalties.

3.4 Cleanliness and Tidiness

- Mooters must maintain a high standard of cleanliness and tidiness in their rooms and communal areas.
- Persistent failure to maintain cleanliness may result in warnings, penalties, or disqualification.

3.5 Respect for Privacy

- Mooters must respect the privacy of others and refrain from entering another participant's room without permission.

- Mooters are not permitted to leave the accommodation premises without prior written permission from the competition organizers.
- Any unauthorized absence will be considered a serious breach of the rules and may result in immediate disqualification.

4. Emergency Protocols

4.1 Emergencies

- In case of any emergency, Mooters must follow the designated emergency protocols and immediately notify the competition organizers.
- Non-compliance with emergency procedures will result in disciplinary action.

5. Noise And Loud Music

- Mooters must maintain a quiet environment within the accommodation, especially during night hours. Loud music or disruptive noise is strictly prohibited.
- Violation of this rule may result in disciplinary action, including disqualification from the Competition.

6. Disciplinary Actions

6.1 Disqualification and Dismissal

- Any violation of the above rules may result in immediate disqualification from the competition, dismissal from the accommodation, and notification to relevant authorities where applicable.
